The Registration Form is required. GlobalED will as a courtesy to our students allow them to enroll in our online courses prior to our receipt of the Registration Form. If the Registration Form is not received by us within 24 hours of your enrollment, we will deny the student further access until such time as the completed and signed enrollment form is received. Course registration and payments are non-transferrable.

REGISTRATION: State Examination

The New York State Insurance Department's (NYSID) has contracted with PSI Exams, Inc as their examination vendor. The fees and procedures to register and take your examination are established by the NYSID and the appropriate examination vendor. Exam Registration and Exam Scheduling information is outlined in the New York State Licensing Information Bulletin available at Department of Insurance website; the Exam Vendor website; and the Global Education website.

GLOBAL EDUCATION INSURANCE INSTITUTE will register you with PSI Exams, Inc. for a non-refundable \$16 handling fee. The GlobalED Insurance Institute handling fee is in addition to the \$49 Licensing Examination Fee charges by PSI Exams, Inc. are non-refundable.

ATTENDANCE

GLOBAL EDUCATION INSURANCE INSTITUTE **does not offer retail classroom** courses to our students. The only classroom instruction is through Institutions who contract and pay GlobalED to provide classroom instruction exclusively to their employees and only at employer provided facilities.

The New York State Insurance Department regulates insurance Pre-Licensing classroom course and requires a **100% attendance policy**. Tardiness and absences must be made up before a Certificate of Completion can be issued. This may be accomplished by auditing a class to make up missed material or by making private arrangements with the Institute and/or instructor to make up missed sessions.

Review Classes are required by New York State Insurance Department. Therefore a Certificate of Completion will be issued at or after attending the required Review Class. GLOBAL EDUCATION INSURANCE INSTITUTE has instituted a Good Attendance Policy whereby the classroom instructor maintains the attendance roster. The attendance roster is kept at the Institute Administration address at all times and made available for inspection by the NYSID.

Attendance will be taken in the following manner: (1) Sign-in sheet when class begins; (2) Sign-in sheet upon return from lunch/dinner break

Online courses are available via the Internet 24/7 and there are no attendance or online time requirements.

GRADING

Certificates of Completion will only be issued to enrollees who pass the Monitored Final Examination or retake Final with a minimum passing grade of 70%. Online Students must qualify for the Monitored Final Exam by obtaining two consecutive practice exam score in the mid 70's range. Qualification standards are subject to change without notice by GlobalED Insurance Institute.

CERTIFICATES OF COMPLETION

CLASSROOM

Attendance: New York State Insurance Department requires a **100% attendance policy** before a Certificate may be issued to any candidate. Any tardiness or absences must be made up before a Certificate can be issued.

Examination: New York State Insurance Department requires a minimum passing grade of 70% on all prelicensing examinations. No Certificate will be issued until such time that each candidate can successfully pass the Monitored Final Examination with a minimum passing grade of 70%.

Review Class: In addition to the mandated 100% attendance policy and the passing of a Final Examination with a minimum score of 70%, the New York State Insurance Department requires attending a REVIEW CLASS for all classroom courses. For this reason, Certificates of Completion will be issued after the completion of the required Review Class and only if all other requirements are satisfied. For example, if a candidate has 100% attendance and is present at the review class but has not yet passed the Monitored Final Exam (MFX), the Certificate of Completion will not be issued until such time the candidate passes the MFX. Any deficiency in meeting any of the above requirements will deny a licensing candidate the issuance of a certificate of Completion.

The New York State Insurance Department requires that Certificates of Completion be PERMANENTLY kept by the licensee and reserves the right to demand production of the Certificate upon request, audit or inspection.

ONLINE

Online Courses: In addition to classroom courses, the New York State Insurance Department has Approved GLOBAL EDUCATION INSURANCE INSTITUTE as an Online Course and Online Final Examination Provider. Our approved online courses fulfill the Pre-Licensing Education Requirement established by the NYS Insurance Department.

Qualification: New York State Insurance Department requires candidates take each chapter or Module in sequence and pass a chapter quiz before being allowed to progress to the next chapter. All chapter quizzes must be passed with a minimum score of 70% before being allowed to take a Monitored Final exam.

Practice Exams and Exam Sims: GlobalED has strict qualification guidelines before a student may take their MFX. These guidelines are subject to change from time to time but under no circumstance will any student be allowed to take a Monitored Final Exam without first passing at least one practice or simulated exam. GlobalED offers unlimited practice or simulated examination attempts to qualify for the Monitored Final Exam.

Monitored Final Examination: New York State Insurance Department requires candidates take and pass a *Monitored* Final Examination with a minimum passing grade of 70%. No Certificate will be issued until such time that each candidate can successfully pass the Final Examination with a minimum passing grade of 70% and the Approved NYS Monitor submits an Affidavit and Monitor Approval Document to the Institute. The Final Examination may be taken online or a special request may be made for a paper examination.

Preferred Monitors: GLOBAL EDUCATION INSURANCE INSTITUTE maintains a Preferred Monitor Directory (PMD). **All students enrolling in a prelicensing course are *required* to use a GlobalED Preferred Monitor Directory for their *First* Monitored Final Exam.** Any student not using our Preferred Monitors for their *first* Monitored Final Exam may be subject to paying out of pocket monitor fees for their examination. GlobalED will not pay any monitor fees to anyone not listed in our Preferred Monitor Directory nor will we reimburse any student for using a monitor not listed in our PMD. The PMD is available in the online course to all students after they pass their first Practice Exam or Exam Sim.

Retake Monitored Final Examinations: Any student who fails their first MFX and needs to retake a Monitored Final Exam are required to pay monitors directly for all exams taken. Monitors determine their own fees. Only one Monitored Final Exam is included in tuition. Only approved NYS Insurance Department monitors are qualified to Monitor NYSID examinations. A student may contact any NYSID approved monitor for retake examinations. Any student in arrears for using a Monitor listed in our PMD will not be issued a Certificate of Completion until the Monitor informs us that the student is no longer in arrears.

Monitored Exam No Show: If a student fails to cancel a scheduled MFX (first or retake) with their Monitor they will be charged for that session. If a student no shows for the first MFX they will lose their one free MFX. If a student no shows for a retake MFX they will be required to pay the Monitor out-of-pocket or the Institute. **NO CERTIFICATES OF COMPLETION WILL BE ISSUED** for any student in arrears with any fees or other financial obligations to the Institute or a Monitor.

Insurance Department Approved Monitor: Monitors are Approved by the New York State Insurance Department and authorized to Monitor Final Examinations and submit a Monitor Affidavit. GlobalED Insurance Institute is a New York State Approved Monitor and is authorized to appoint competent individuals to Monitor Final Exams administered by us or by another approved provider. School appointed Monitors will not appear on any NYS Insurance Department Approved Monitor Lists. Confirmation by GlobalED Insurance Institute is all that is required to confirm the Identity of a GlobalED appointed monitor.

Monitor Affidavit & Approval Documents: No Certificate of Completion will be issued to any student completing our course prior to the Institute receiving a Monitor Affidavit signed by both the student and the Monitor; and the Institute receiving a valid copy of the Monitor Approval Document issued by New York State Insurance Department. A listing of approved monitors may be obtained at the New York State Insurance Department website: <http://www.ins.state.ny.us/iabedu.htm>

Course Expiration: All courses expire upon successful completion or 180 days after enrollment or last log-in date. No Refund shall be payable for expired courses.

Reinstatement Period: If a course expires a student may reinstate within 180 days after course expiration upon payment of the Registration Fee in effect at the time of reinstatement plus any difference in course price that may exist at the time of reinstatement. Enrollment beyond the reinstatement period shall be at full price.

Course Transfer: A refund calculation shall be performed. The refund due shall be applied as a credit to the new course. If no refund is due, only a **new registration fee shall be required.** .

Course Transfers Due to Change in the Licensing Exam: If the student has **not passed the MFX:** the payment of a **new registration fee and any increase in tuition shall be payable.**

If the student has **passed their MFX** but was unable to take the licensing exam due to no available examination dates remaining, the **registration fee shall be waived.** The student will be required to pay a tuition increase (if any) for the new course.

REFUNDS

Candidates who cancel within 7 days of signing the Registration Form but before signing into their course for the first time receives all monies paid with the exception of the **non-refundable registration fee;** the **non-refundable book and shipping costs;** and the **non-refundable Examination Fees.** Thereafter, students have a **Tuition Liability** as of the student's last module completed. The percentage refund is calculated in accordance to the Mini Refund Policy below.

The Online course percentage of the program completed shall be determined by calculating the number of chapter quizzes taken for each module by the number of total learning modules in the course.

Course Expiration: All courses expire upon successful completion or 180 days after enrollment or last log-in date. No Refund shall be payable for expired courses.

Any refund due a candidate shall be paid by the school within **forty-five days** of the date on which the candidate withdraws from the program and makes such written request for a refund. All refund requests must be

in writing and sent to the Administration Office with the words REFUND REQUEST in the subject line. All refunds are payable by check and processed once per month on the third Friday of the month. Refund Checks are mailed to the student's address of record. Any student request for a second refund check will be assessed a \$50 stop check fee.

Optional State License Examination Fee: **License Examination Fees are Non-Refundable**. See the Examination Fee Policies listed in the New York State Insurance Department Licensing Information Bulletin. You have the option of registering yourself for the Licensing Examination or have Global Education Insurance Institute register and schedule your examination with the appropriate Licensing administrator. We charge a \$16 Non-Refundable Handling Fee for registering students for PSI Examinations. This fee is in addition to the to \$49 non-refundable registration fee charged by PSI Exams, Inc.

The failure of a candidate to immediately notify the Institute director in writing of the candidate's intent to withdraw may delay a refund of tuition to the candidate pursuant to section 5002(3) of the Education Law. Adherence to the above instructions is deemed to be notification of the Director.

PRIOR CREDIT

If any candidate has a valid Certificate of Completion (a valid Certificate of Completion is one issued by a NYSID approved provider) or an expired license issued by the NYSID are exempt from taking another prelicensing course. Students may enroll in a course as preparation for the state examination but will not be issued a Certificate of Completion.

CONDUCT

Any student not acting in a professional, ethical and trustworthy manner; shows disrespect to other students, faculty or staff; does not follow course requirements or instructor amended course assignments; Does not adhere to instructor guidance and recommendations; Speaks or communicates in a derogatory manner toward any person taking the course or toward us will be subject to appropriate disciplinary actions which may include removal from the course any denial of further use of our services. Removal for conduct reasons nullifies the right to any refund.

STANDARDS of PROGRESS

Attendance records and examinations shall be maintained for every course participant. The participant agrees to provide GLOBAL EDUCATION INSURANCE INSTITUTE a faxed or mailed copy of their Licensing Examination Score Report. We collect this data to maintain a record of "Candidate Passing Ratios." If classroom and online instruction is not an adequate means for you to absorb the required material, private tutorials are available to candidates at an additional fee and a minimum of two contact hours of private instruction time. Private Tutorial Fees are subject to change but start at \$50 per contact hour where an hour is equal to 50 minutes.

PASSING RATIOS

Diligent efforts to maintain accurate records of students completing our program and taking their state examination are maintained and available upon request. Information on the number of course graduates

who pass their respective licensing examination on their first attempt is available upon request.
